





## CorpFiling | Corporate Filing & Dissemination System

### Instruction set for filing Share Holding Pattern

#### **MAKER**

Login with the maker's ID, select "New Share Holding Pattern Filing Template" from the "Share Holding Pattern" option in the "CorpFiling" menu. The Share Holding Pattern wizard will be loaded. Please select a quarter in the wizard and click on continue to generate the template.

Please ensure the following conditions are met while entering the data in the template :

1.Total (No. of Shares & Percentage ) of (I)(b) Promoter and Promoter Group should be match with Total of (A)=(A)(1)+(A)(2).

2.Name under (I)(b) "Promoter and Promoter Group" not greater than Total Number of Shareholders of A.

3.Total (No. of Shares & Percentage ) of (I)(c) "Public" should be less than Total of (B)= (B)(1)+(B)(2).

4.Name under (I)(c) "Public" not greater than Total Number of Shareholders of B.

5.Total of (II)(a) is less than or equal to C.

6.Total of (II)(b) is less than or equal to (II)(a).

7.Number of Shareholders can not greater than Total number of shares.

8.Number of shares held in dematerialized form can not greater than Total number of shares.

9.Percentage of (I)(c) "Public" should be 1% or more than 1% & not less than 1%.

10.Percentage of (II)(b) should be 1% or more than 1% & not less than 1%.

Once you have filled the templates, go to "CorpFiling" option in the toolbar, go to "Share Holding Pattern" and click on "Upload Share Holding Pattern".

Enter the Login ID and password of the maker in the window, which is popped up, and then click on Submit. After that you will get a confirmation message of upload of Share Holding Pattern.

Then logout from the maker's ID.

With this maker has created and uploaded the filing. It will now be available for the checker to view and approve.

#### **CHECKER**

Login with the checker's ID.

Go to "CorpFiling" option in the toolbar, go to "Share Holding Pattern" and click on "Verify Uploaded Share

It will automatically download the Share Holding Pattern Filing created by the maker.

You can go through the information filed by the maker. Once that's done, go to "CorpFiling" option in the toolbar, click on "Share Holding Pattern" and select "File Verified Share Holding Pattern".

Enter the Login ID and password of the checker in the login window.

Followed by that, there will be another window with 3 options; you can choose any one of them.

1. Approve and file
2. Reject
3. Cancel

You can provide the maker with your comments. These will be mailed to the maker.

If you have approved the filing, follow the steps of the digital signing wizard.

After you attach and send the digital certificate, you will get a message stating 'Data signed successfully'.

After clicking on Ok, you will get a confirmation message that your filing has been forwarded to the exchanges, and you will get an acknowledgement by an e-mail.

As a checker you also have the rights of a maker, and you can make a new filing. Please follow the instructions listed under the maker to make a new Share Holding Pattern filing.
